PART II - TERMS AND CONDITIONS

Transportation customers taking service under the Company's Gas Transportation Service Rate Schedules may elect to participate in the Group Transportation Service Program ("Program") by submitting a Group Transportation Service Program Customer Enrollment Form to a designated group administrator responsible for managing a group of a supplier. The group administrator will be responsible for submitting enrollment forms to Consumers Energy Company ("Company") on behalf of those transportation customers who have voluntarily agreed to participate in the Program and join the specified group. Enrollment forms must be received by the Company by the first business day of the calendar month 60 days preceding the transportation customer's enrollment in the group and must be processed with an effective date corresponding to the first day of a calendar month. Within ten (10) business days after receipt of an enrollment form, the Company will notify the group administrator of the current enrollment status. By enrolling in the Program, a group administrator, on behalf of the group's supplier, can aggregate the receipts and deliveries of those gas transportation customers who have enrolled in the group and can provide the Company with a single supply nomination on behalf of those transportation customers. The Company will then transport gas for the group from the points of receipt to the transportation customers within the group.

Transportation customers enrolled in the Program will remain subject to both the obligations of the Company's Gas Transportation Rate Schedule under Section E of the Company's Natural Gas Rate Book, through which that transportation customer takes service, and the transportation customer's Gas Transportation Service Contract. In addition, transportation customers will remain subject to the provisions of the Company's Natural Gas Rate Book. Transportation customers will also continue to be billed under the Gas Transportation Rate Schedule designated on their Gas Transportation Service Contract, which shall not become the responsibility of the group administrator. However, authorized gas will not be available under the Program, and group members will not be subject to the unauthorized gas usage charge or load balancing charge as set forth in the Gas Transportation Rate Schedule under Section G of the Company's Natural Gas Rate Book, which will become the responsibility of the group administrator. Group administrator shall also be responsible for all applicable monthly fees under the Program, as set forth under Section G of the Company's Natural Gas Rate Book.

At the time of enrollment, transportation customers must submit all transportation accounts with the group. In doing so, transportation customers agree to be enrolled in only one group at any time and will not be eligible to designate receipts of natural gas from any source other than the group in which they are enrolled. In addition, all transportation customers enrolled in a group shall have the same authorized tolerance level. If a transportation customer wishes to enroll other accounts that are not included in the transportation customer's Gas Transportation Service Contract, the Gas Transportation Service Contract must first be amended before the accounts can be included in the group. If a transportation customer acquires additional transportation accounts after enrollment in a group, the transportation customer must notify the Company to ensure the newly acquired transportation accounts are included in their group. In the event that the Group has reached the 100 contract account enrollment limit, any transportation customer enrolled within the group will not be permitted to include newly acquired accounts within their Gas Transportation Service Contract and the group. All transportation accounts in excess of the 100 contract account enrollment limit shall be removed from the Company's Transportation Service Program and placed on an applicable General Service Rate Schedule under Section D of the Company's Natural Gas Rate Book.

Upon joining a group, any volumes in a transportation customer's authorized tolerance level balance will transfer into the group administrator's group authorized tolerance level balance. Upon leaving a group, a transportation customer's authorized tolerance level will follow that transportation customer, and the group administrator's group authorized tolerance level will be reduced by that transportation customer's authorized tolerance level.

Enrollment in a group shall remain in effect for a period of at least twelve (12) months from the date of the enrollment. The transportation customer's selection of a group shall be effective until: (i) terminated by the transportation customer or the supplier, (ii) the supplier becomes disqualified from participating in the Program, (iii) the Company receives an enrollment for that transportation customer for another group, (iv) group administrator's contract with the Company is terminated subject to Section G of the Company's Natural Gas Rate Book, or (v) as otherwise provided in the Company's Natural Gas Rate Book.

A group will be terminated, and the transportation customers of that group will be removed, if the group administrator's unpaid administrative fees, customer account maintenance fees, and group failure fees exceed any cash deposit or alternative assurance accepted by the Company. In the event the group is terminated, any gas retained by the Company for that group must be transferred to another group or to a transportation customer taking service under a Gas Transportation Rate Schedule.

Any transportation customer with an account in arrears will not be eligible to enroll in a group or participate in the Program. In addition, as a requirement to participate in the Program, transportation customers must enroll in the Company's electronic billing program, business e-Bill, or an electronic invoice delivery program as determined by the Company. It is the responsibility of the transportation customer to give access to the group administrator to view the transportation customer's bill.

This document may be generated or delivered by facsimile or electronic transmission, which shall be deemed an original, and may be imaged and stored electronically and introduced as evidence in any proceeding as if the original business record. Neither the Group Administrator, Transportation Customer, nor the Company will object to the admissibility of such images as evidence in any proceeding on account of having been stored electronically.

Submission of this form does not guarantee the transportation customer will be accepted into the Program.
