REMOTE METER RELOCATION PROGRAM

Consumers Energy Company, your natural gas provider, is regulated by the Michigan Public Service Commission. Our gas metering practices have been reviewed and we are required to change certain gas meter installations. Residential meters are required to be attached to homes in order to insure that the gas fuel line to the residence is installed and maintained by Consumers Energy. Some customers have meters that were installed away from and not attached to their homes. These customers have been responsible for the installation and maintenance of portions of the gas fuel lines from the meter to the residence.

Consumers Energy is committed to relocate remotely installed outside residential meters. The purpose of this program is to eliminate customer maintained buried fuel line that is required to be maintained in accordance with applicable State and Federal codes. To perform the work we will require access to our equipment and your home. The Rules approved by the Michigan Public Service Commission allow us to relocate our gas equipment.

The remote meter at your address is part of the program. Consumers Energy will:

- Install a gas meter on the outside of your home,
- Replace the existing fuel line with a code compliant service line,
- Remove above ground gas equipment at the remote meter location, and
- Abandon the existing fuel line in place.

The relocated meter will be installed as close as possible to a location over where the existing natural gas fuel line enters your home. You may ask that the meter be located at a different location on your home. However, please be aware that there may be a charge for an alternate location.

This work will be done at no cost to you. Within 15 calendar days, please:

- Contact me so we can discuss this program further, or
- Return the enclosed Agreement to Relocate Remote Meter.
