

Rebate Eligibility Requirements

- Applicant must be a Consumers Energy residential electric customer. Limit of one rebate per year, per household.
- Pump must be a new ENERGY STAR certified variable speed pool pump, replacing an existing pool pump. Newly installed pools are not eligible for rebate.
- Application must be postmarked within 30 days of installation.
- All customer, installer and product information must be completed in full.
- Please have your Consumers Energy residential electric account number handy when applying.

Rebate Documents for Submittal

- A copy of dated sales receipt/paid invoice showing manufacturer, model number, installation date, purchase price and vendor name.

Pump must be present on the ENERGY STAR certified products list as of the date of purchase in order to qualify for rebate. Terms and conditions are subject to change without notice, including early termination of this promotion. No additional fees apply. Please allow 6-8 weeks for payment (in the form of a check). Payment processing may take longer if information is missing on the application. Additional terms and conditions apply.
