#### **Dues Changes**

Since the formation of the Forerunners, our dues structure has been \$5 per year. Almost 15 years ago, we created a Lifetime Membership of \$25. A few years later, the Lifetime Membership was increased to \$50. This kept us afloat for many years. However, the Lifetime membership has outlived its usefulness and has been discontinued. Of course, those who already are Lifetime members will retain that membership.

The annual dues have been set at \$10/year beginning January 1, 2016. We believe we can provide more service with this increase without it being a burden on our members. We have been subsidizing, to a limited extent, some of our activities. With rising costs from food suppliers and event venues, our hope is to keep the current level of charges for our activities as well as continue our scholarship program and other benefits currently offered.

#### **Online Directory**

As you know, the world is fast becoming much more electronically "plugged in" and we are no exception.
