ELECTION UPDATE



The summer will begin the election process to choose a new Governor and other elected officials for the State of Michigan and the Federal Government. These election dates are very important, and as a registered voter in the State of Michigan, you have the opportunity to choose your candidate from the three major parties. The primary election is August 7, 2018, and this is a closed primary so you may only vote for one major party, Democrat, Republican or Libertarian. You may choose from a list of people who are running for a specific office within that party. The candidate receiving the most votes will then be placed on the November ballot. November 6, 2018, you may vote for any candidate no matter their party affiliation, and you do not need to vote the party line. So get out and vote both dates for whoever you believe will be the better person to represent you in Michigan and Washington.



The Forerunners Board and many local Chapters are looking for new leadership in many positions. The Forerunners will have a Vice President vacancy at the end of 2018, and the Presidency will be vacant at the end of 2019.
