### 2021 Forerunners Scholarship Information



If your graduating high school senior has not yet applied for our scholarship, there is still time.

**ELIGIBILITY REQUIREMENTS**: \*Children/legal dependents \*Grandchildren \*Step-children \*Step-grandchildren of Forerunners members. Applicant needs to be a graduating high school senior with a cumulative grade point average of 2.5 or above and is planning on following a full-time program of first-year student at a college, university, post-secondary, or trade school. Only one scholarship is awarded per year, to a Forerunner member. Forerunners membership dues payment must be current.

**SELECTION CRITERIA**: Selection of the scholarship recipients will be by a lottery-type drawing overseen by the Forerunners Scholarship Committee.
